**Gary's Green Ultra®** contains **Ultraplex®** which is a unique formula in which no additional surfactant is required.

**IMPORTANT:** For best results apply as a foliar spray early in the morning or late evening. Allow to dry 3-6 hours before irrigation.

**COOL SEASON TURF GRASSES:** As a foliar - maintenance rate 6-9 oz. per 1000 sq. ft. Severe deficiency rate 9-12 oz. per 1000 sq. ft. weekly or as needed.

**WARM SEASON TURF GRASSES:** As a foliar - maintenance rate 9-12 oz. per 1000 sq. ft. Severe deficiency rate 12-15 oz. per 1000 sq. ft. weekly or as needed.

Foliar fertilizer is intended as a supplement to a regular fertilization program and may not, by itself, provide all the nutrients normally required by plants.
