## **Directions For Use**

- Read the entire label before use.
- Apply only as directed during the growing season.
- Apply only to dry foliage.
- Irrigating after application will accelerate initial green-up and will aid in the downward movement of granules into the turf canopy.
- Apply after mowing to prevent particle pick-up by mowing equipment. To further reduce particle pick-up do not collect clippings for one mowing after application.
- Nutrite encourages responsible use of our products. Help do your part in protecting our rivers and lakes by following label directives and cleaning driveways and walkways after application. Do not apply near water storm drains or drainage ditches, if heavy rain is expected or frozen ground.

To provide proper distribution, calibrate spreader before application.
